In order to safeguard your privacy, we will never share personal information (like your name) with anyone outside the research team. Your data will be referred to by a unique participant number rather than by name). Please note that we will temporarily collect your Prolific ID to prevent repeat participation, however we will never share this information with anyone outside the research team. We will store any personal data (i.e., Prolific ID) using the University of Edinburgh's secure encrypted storage service. The anonymised data collected during this study will be used for research purposes.
